4. 2018-19 AUDITED FINANCIAL STATEMENTS

Discussion

Jeff Alliston of Metrix Group presented the 2018-19 Audited Financial Statements of Rehoboth Association and Rehoboth Foundation. He had a PowerPoint presentation which explained why audits are done, the role of the auditor, and benefit to the organization. He reviewed the financial statements, noting movement of assets during the year from the Association to the Foundation and touched on other items of note.

Question from floor was raised about the reliance on PDD funding and wondering whether the political change in the province will impact funding stability. Ron Bos responded with observation that new government is not providing a budget and the expectation is the funding will remain stable.

Stefan Dykema offered insights as the Board Treasurer. Rehoboth is in good position financially.
